Soundness

Once legal compliance has been established, the London Plan is assessed against the four tests of soundness set out in national planning policy and detailed below

- **Positively prepared:** The plan meets objectively assessed development needs, including unmet requirements from neighbours, consistent with sustainable development
- **Justified:** The plan is the most appropriate strategy when considered against reasonable alternatives, supported by proportionate evidence
- **Effective:** The plan is deliverable over its period and based on effective joint working on cross-boundary strategic matters
- **Consistent with national policy:** The plan enables the delivery of sustainable development in accordance with the policies in the [National Planning Policy Framework](#)
